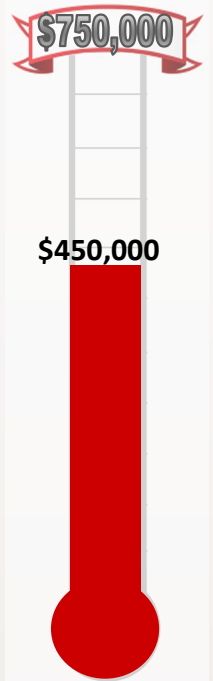




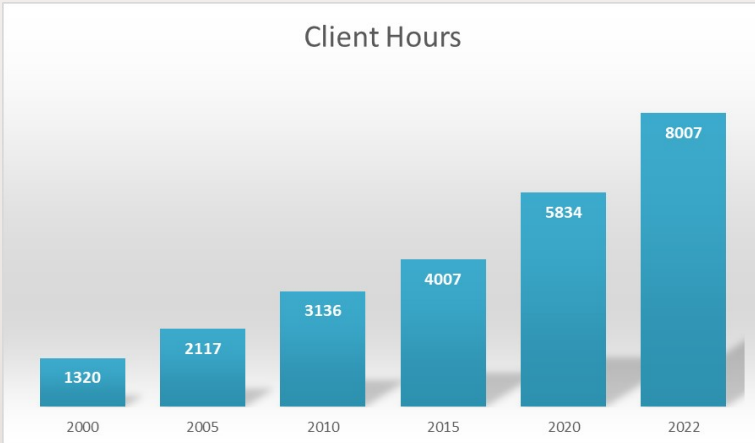
# Northland Christian Counseling Center

We are amazed and humbled by how God has grown this organization over the last 30+ years. In the 1990s, pastors in the Grand Forks region began discussing the need for professional Christian counseling in our area. NCCC began with 1 clinician working 1 day a week. We have now grown to 9 clinicians working Monday through Friday. In 2022 we hit 8,007 client hours! We are currently in offices at Faith E. Free Church and a location in the Grand Cities Mall, but our desire is to unite our ministry into one location and provide more office space for future growth. The Lord has blessed us, and we pray He will continue to bless us as we serve this community in a ministry of restoration.

## GIVING CHOICES
